

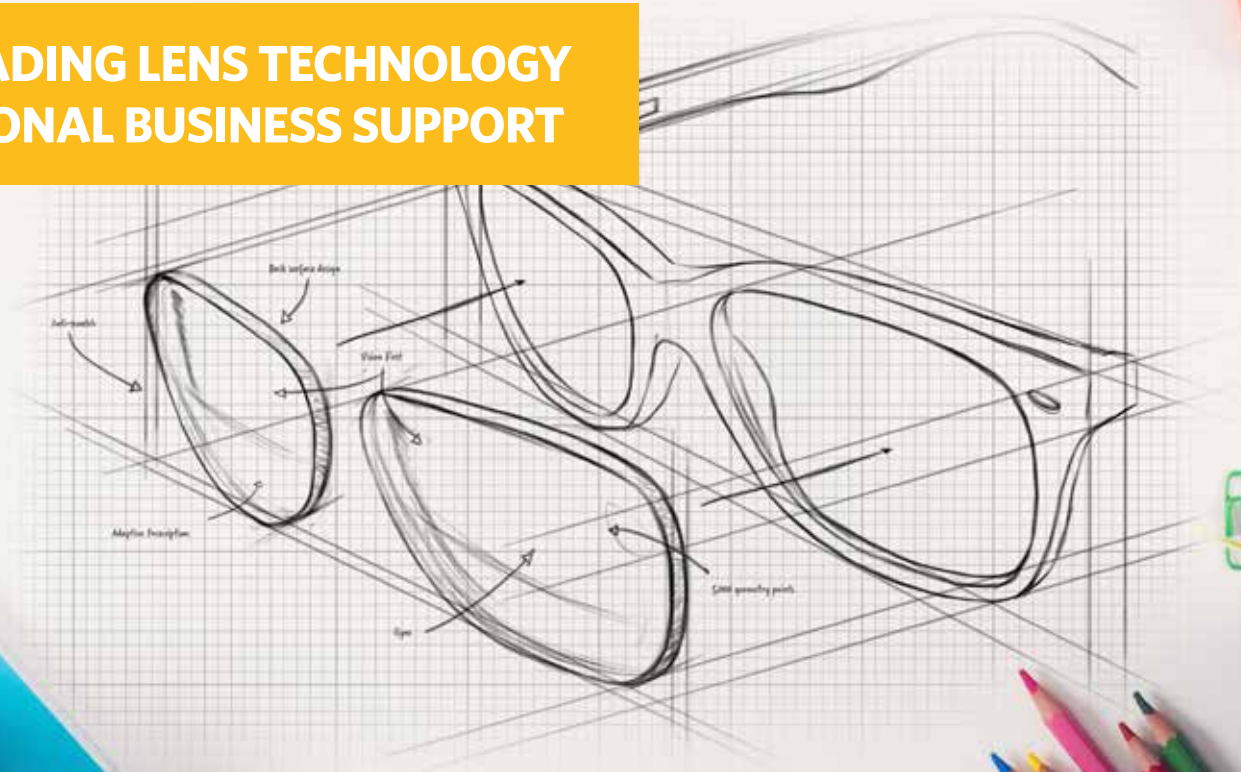

ONLINE ORDERING & REMOTE EDGING

You will find the KODAK Lens online ordering system familiar and easy to use. Via an easy two-step process you can trace the patient's frame and place your order online with full tracking capability from start to finish.

We are able to process shapes from most tracers currently on the market and can accept a large number of different frame and prescription combinations. For frames that are difficult to trace accurately or lens powers that are +/- 6.00 with up to 3.00 cyls we recommend you send the complete order into our world class glazing department.

We recommend you use a surfaced lens for supra frames, please contact us for further advice.

UNSUITABLE FRAMES

We do not recommend you trace any of the following frame types if you require the lenses to be remotely edged. The frames do not produce good results due to the nature of the materials used or the actual design of the frame. We will however, use the frame trace for reducing thickness on uncut lens orders only.

1. Titanium metal frames
2. Double rim metal frames
3. Thin flexible plastic frames
4. Inline metal supra frames
5. Frames with a B measurement of less than 23mm
6. Wrap frames or frames with a wrap angle of more than 10°

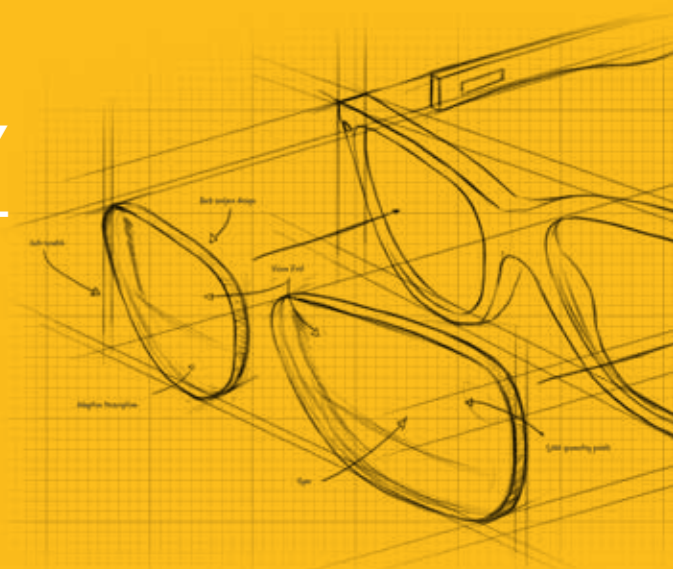

DIGITAL FREEFORM

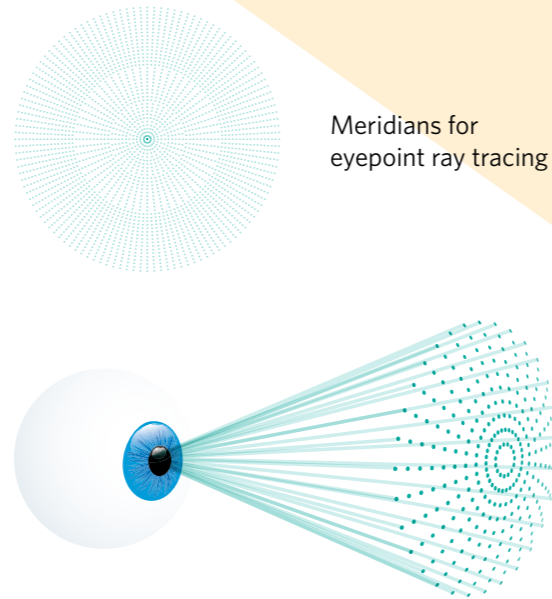
All KODAK Lens Digital Lenses benefit from digital freeform processing which provides optical improvement as well as being thinner and flatter in comparison to standard lenses. Digital freeform processing is achieved via a single point diamond tool precisely guided by a computer to allow three dimensional surfacing along x, y and z axis. As the lens spins, the diamond cutting tool tracks across the lens, providing a smooth finish.

Meridians for eyepoint ray tracing

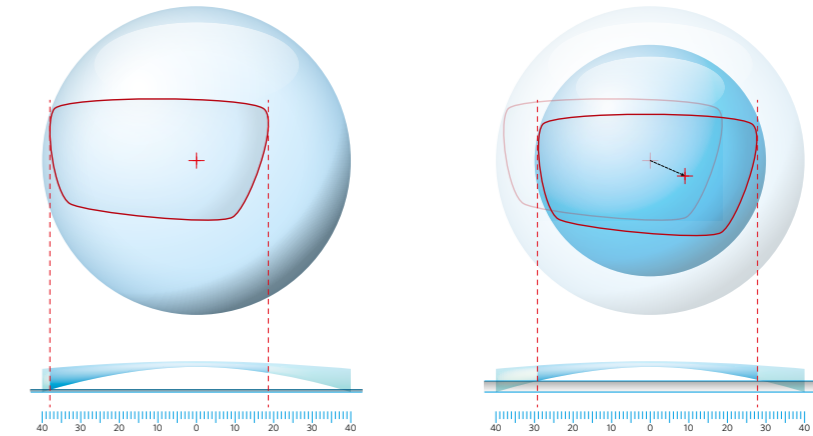

VARIABLE DECENTRATION

Variable Decentration allows the design of the lens to be repositioned within the blank which enables smaller lenses to be used. This in turn will produce a more balanced edge thickness nasally, temporally and at the top and bottom of the lens. Applies to all KODAK Lens Digital Lenses.

VARIABLE CORRIDOR LENGTH

Fashion often dictates the progressive lens choice. Applicable lenses are designed using key point referencing, allowing the same design principles to be applied to varying corridor lengths, thus making it a family of lenses that can be used for frames whatever their shape or size (from a minimum fitting height of only 14mm). The direct correlation in design between lenses with shorter and longer corridors results in excellent visual comfort regardless of frame choice.

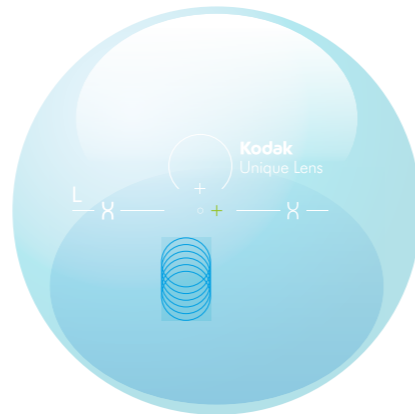
SELF SELECT CORRIDOR LENGTHS

Products with variable corridor lengths are available to order in 2 ways:

- 1) Specifying frame measurements and prescription details, allowing complex software to select the most appropriate corridor length for your patient.
- 2) Specifying the preferred corridor length. By self selecting the corridor length, you are able to match the corridor length of your patient's existing progressive design in order to maintain similar head posture and eye rotation.

VISION FIRST DESIGN™

Vision First Design™ provides a smooth mean power profile. As the eye travels across any horizontal area in the lower portion of the lens it will normally encounter many changes to mean power (diagram A). With Vision First Design™, the desired optical performance is specified, then the calculations needed to provide optimum results are calculated. This is opposite to how traditional progressive lenses are designed; firstly defining the geometry of the surface then analysing the optical performance. If the performance is not satisfactory the process is repeated.

Vision First Design™ allows the designer to incorporate binocular balance into the lens (diagram B). Providing a balanced visual experience throughout the lens.

without Vision First Design™

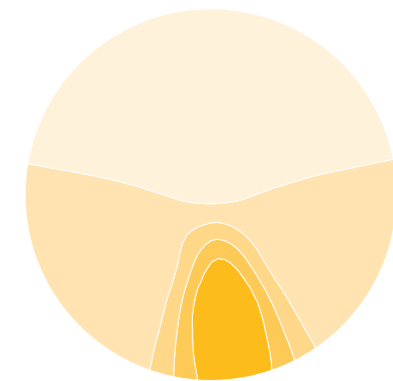


DIAGRAM B

iSYNC™ TECHNOLOGY

iSync™ Technology uses precision optical and mathematical calculations within a complex software program. This program incorporates the results of ray tracing over the entire surface of the lens to correct oblique power errors that occur when viewing away from the optical centre.

Results of the final design enhance the visual experience by providing sharper, clearer and wider viewing areas. Each lens is designed for the right and left eye providing the widest viewing area at the most important part of the lens.

The table to the right demonstrates how iSync™ Technology effects the area of vision. As you can see, the unwanted astigmatism has disappeared from the distance area and the astigmatism free reading area has widened.

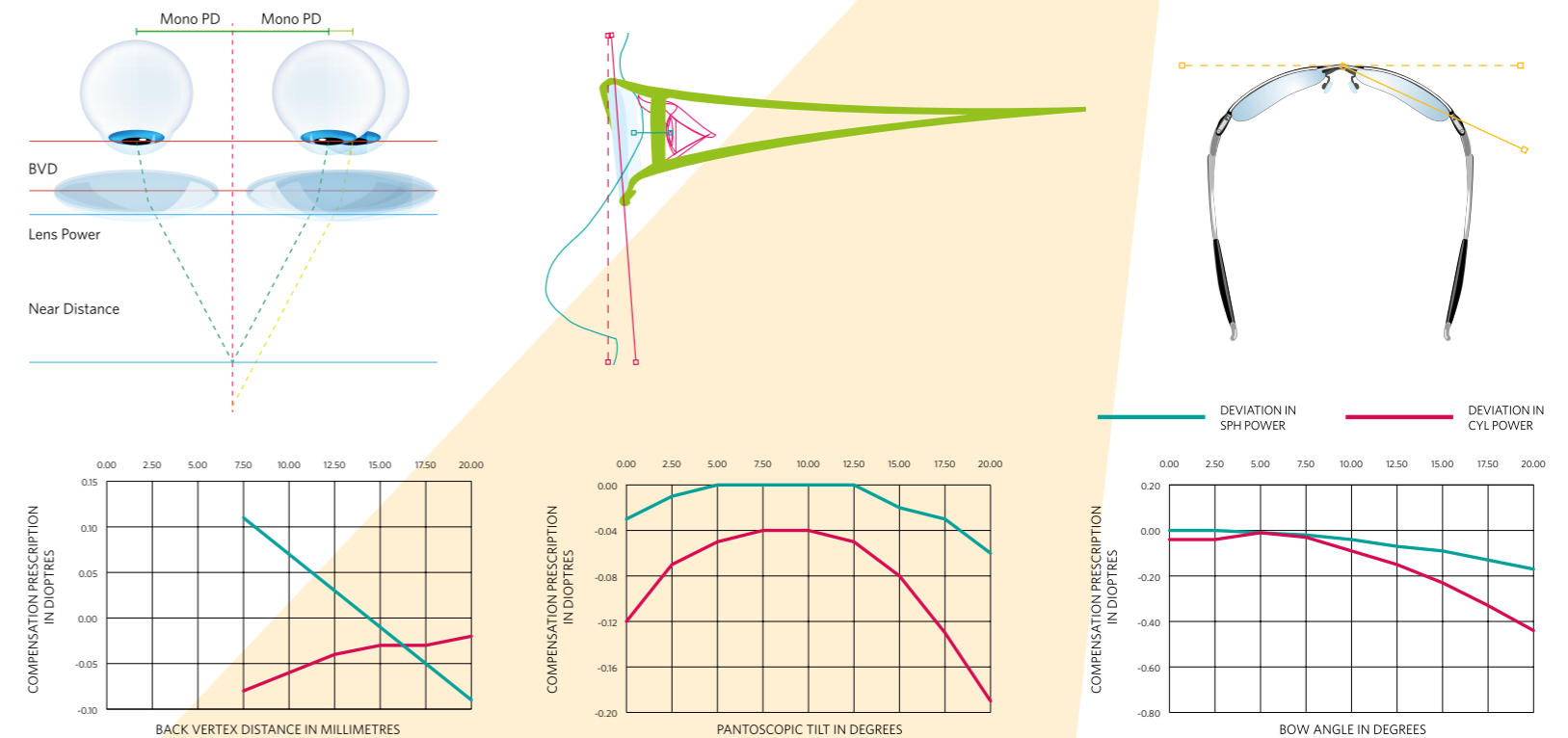

When glasses are being worn, the way a patients chosen frames sit on their face can dramatically alter the viewing experience through the prescribed powers.

With Adaptive Prescription the patient's Back Vertex Distance (BVD), pantoscopic tilt and face bow are calculated via a computer to create a compensated lens that has been optimised for that individual patient.

Depending on the frame position and prescription, Adaptive Prescription can dramatically improve the patient's viewing experience.



1. Definitions

In these conditions

"the Company" means Signet Armorlite Europe Limited
"the Customer" means the individual firm company or other party with whom the Company contracts.

"Supply" includes (but is not limited to) any supply under a contract of sale. For the purposes of these conditions a quotation shall include the listing of a product in the Company's current price list as varied by any authorised representative of the Company.

2. General

- Previous dealings between the Company and the Customer shall not vary or replace these terms or be deemed in any circumstances whatsoever so to do.
- No order in pursuance of any quotation or otherwise shall be binding on the Company unless and until such order is accepted by the Company either in writing (which shall include e-mail acknowledgement) or by despatch of the goods ordered. In the case of orders placed through the Company's website, the Customer accepts these conditions by submitting such order. Any contract made between the Company and the Customer (herein called "the Contract") shall be subject to these conditions and save as aforementioned no representative or agent of the Company has authority to agree any terms or make any representations inconsistent with them or to enter into any Contract except on the basis of them; any such terms representations or Contract will bind the Company only if in writing and signed by a director.
- Unless otherwise agreed in writing by the company these conditions shall override any terms and conditions stipulated or referred to by the Customer in his order or pre-contract negotiations.
- Any description contained in the Company's catalogues, samples, price lists or other advertising material is intended merely to present a general picture of the Company's products and shall not form a representation or be part of the Contract. All promotional material, price lists, catalogues and other documents prepared by the Company together with the "Presenter" provided for the Customer's use are and will at all times remain the property of the Company and without prejudice to the generality of the foregoing, no drawings or information therein may be copied or reproduced in whole or in part or divulged or transferred to a third party except in the promotion of the Company's products without the Company's written consent.
- In the event that the Company has not given a written acknowledgement of the Customer's order these conditions, provided the Customer shall have had prior notice of them, shall nonetheless apply to the Contract.
- The Company reserves the right to correct any clerical or typographical errors made by its employees at any time. Failure by the Company to enforce any of these conditions shall not be construed as a waiver of any of the Company's rights under the conditions of the Contract.

3. Design and Quality

- The goods supplied under a Contract shall correspond as much as possible with the Company's specification of the goods and shall be of merchantable quality but no warranty is given or shall be implied as to the suitability of the goods for any specific purpose.
- The Company reserves the right to make variations in the design and technical specification of the goods without imposing any obligation upon itself to incorporate such changes with products previously supplied.
- The Company does not nor will it assert or warrant the validity of any letters patent registered design or trade mark applying or applied to any goods supplied by the Company to the Customer under a Contract or that any dealing with any such goods is not or will not be an infringement of any patent design or trade mark rights of third parties.
- All goods will be made within reasonable manufacturing limits of dimensions. If special accuracy is required the Customer must state specifically in writing the maximum and minimum limits. The Company accepts no responsibility for the accuracy of information or drawings supplied by the Company.

4. Prices

- Subject to any agreement to the contrary the Company's quotations are provisional and may be altered to take account of any changes taking

place between the date of quotation and the Company's acceptance of the Customer's order in the price of the products to be supplied and other costs of sale (including any such increase arising from adverse movements in the rate of exchange between the £STG and the currency in which the supply to the Company by the relevant supplier is designated) or in the Customer's instructions or in the event that the Customer orders part only of the quantity referred to in any quotation.

- The Company shall be entitled to increase its prices at any time to take account of any increase in the cost to the Company of purchasing any goods or materials (including any such increase arising from adverse movements in the rate of exchange between the £STG and the currency in which the supply to the Company by the relevant supplier is designated)/ (including any such increase arising from any error or inadequacy in any instructions provided by the Customer) and such increased prices ruling at the date of despatch by the Company shall be substituted for the previous Contract price. All prices quoted are exclusive of VAT and the Customer shall pay any and all taxes duties and other government charges payable in respect of the goods.

5. Delivery

- Unless otherwise agreed in writing by the Company the Company agrees to deliver goods to the Customer which shall forthwith give to the Company all necessary instructions to enable such delivery to take place; the Company shall add to the Contract price of the goods a reasonable charge for packaging and delivery and off-loading shall be at the Customer's risk and expense.
- Subject to any agreement in writing by the Company, the risk in goods which the Company agrees to supply within the United Kingdom shall pass to the Customer on delivery or the date (if earlier) on which, the goods being ready for delivery, delivery is postponed at the Customer's request.
- Subject to any agreement in writing by the Company, the risk in goods which the Company agrees to supply outside the United Kingdom shall pass to the Customer in accordance with F.O.B. English Port as defined in Incoterms 1990.
- Should the Customer be unable to accept delivery of the goods at the time when the goods are available for delivery the Company may at its absolute discretion store the goods until actual delivery and the Customer shall be liable to the Company for the reasonable costs of storage handling and carriage. This provision shall be without prejudice to the Customer's liability in damages for failure to take delivery on the contractual date.
- The Company shall not be liable for any loss of or damage sustained by any goods left with the Company howsoever caused and whether or not attributable to negligence on the part of the Company or negligence or willful default on the part of any servant or agent of the Company.
- No claim for damage in transit shortage of delivery or loss of goods will be entertained by the Company unless (1) the Customer shall give to the Company written notice of such damage, shortage or loss either within such time as will enable the Company to comply with the carrier's conditions of carriage or three days, whichever is the shorter, and (2) where the goods have not been checked on acceptance from the carrier, the delivery book of the carrier has been signed "not examined".
- Should the Company be delayed in or prevented from making delivery of the goods due to war, governmental or parliamentary restrictions, strike, lock-outs, fire, floods, explosions, labour disturbances, trade disputes, damage to or destruction of the goods, breakdown of machinery, shortages of labour or of raw materials or Act of God or due to any other cause whatsoever beyond the reasonable control of the Company, the Company shall be at liberty to cancel or suspend the order placed by the Customer without incurring any liability for any loss or damage arising there-from.
- While the Company will endeavour to deliver the goods by any date or within any period agreed upon, such dates and periods are estimates only given in good faith and the Company will not be liable for any failure to deliver by such date or within such period. Moreover, the Company shall be entitled to defer delivery until any monies due from the Customer have been received.
- The Company may deliver the goods in instalments unless otherwise agreed. When delivery by instalments is specified each delivery shall for the purpose of this sub-clause only be deemed to constitute a separate contract and the failure of any one or more deliveries shall not be deemed to be a repudiation of the Contract.

- Save as provided by paragraph 7 hereof the Customer shall not be entitled to return goods or refuse to accept delivery without the Company's prior written consent.

6. Payment Terms

- For the purpose of this paragraph the goods shall mean the whole or any instalment of the goods which the Company has agreed to supply and the relevant date shall be the date on which
 - the Company despatches the goods or
 - the Customer defaults in its obligations under sub-paragraph (b) hereof whichever shall first occur.
- Unless otherwise specified in writing by the Company payment shall be made by the Customer net cash not later than 25 days from the statement date. Time for payment shall be of the essence of the contract. Without prejudice to any other rights of the Company interest will be payable on all overdue accounts at 2% per month and the Company shall be entitled to recover all other costs or expenses incurred and for the purpose of paragraphs 7 and 9 hereof the full purchase price of the goods shall include delivery and packaging charges together with any interest payable and costs hereunder. In the case where overdue balances occur we will add collection costs. The Customer shall not be entitled to withhold or set off payment of any amount payable to the Company under this or any other Contract by reason of any dispute which it may have with the Company.
- Without prejudice to any other terms herein if payments to the Company on any account are delayed beyond the due date for payment or if the Customer shall enter into any composition or any arrangement with his creditors or if the Customer being a corporation shall have an administrative receiver or administrator appointed or shall pass a resolution for winding-up or a Court shall make an order to that effect or if there shall be breach of any of the terms and conditions hereof the Company shall be entitled to withdraw credit facilities from the Customer.

7. Cancellation

- If the Customer shall fail to make any payment when it becomes due or shall enter into any composition or any arrangement with his creditors or if being a corporation shall enter into a corporate voluntary arrangement or have an administrative receiver or administrator appointed or shall pass a resolution for winding up or a Court shall make an order to that effect or if there shall be any breach by the Customer of any of the terms and conditions hereof the Company may defer or cancel any further deliveries and treat the Contract of which these conditions form part as determine but without prejudice to its rights to the full purchase price for goods delivered and damages for any loss suffered in consequence of such determination.
- Cancellation by the Customer will only be accepted at the discretion of the Company and in any case on condition that any costs or expenses incurred by the Company up to the date of cancellation and all loss or damage resulting to the Company by reason of such cancellation will be paid by the Customer to the Company forthwith. Acceptance of such cancellation will only be binding on the Company if in writing.

8. Warranty

- Save as otherwise provided in these conditions and with the exception of goods supplied with specific warranty the Company's liability in respect of any defect in or failure of goods supplied is limited to replacing or repairing or paying for the repair or replacement of goods which within a reasonable period after delivery to the Customer are proved to be defective by reason of faulty or incorrect workmanship or materials PROVIDED that the Company's liability (if any) in respect of any direct loss or damage sustained by the Customer as a result of such defect shall not exceed the price of the goods. Conditions precedent to the Company's liability (if any) hereunder shall be that
 - the goods shall have been subject to reasonable and proper use by the user thereof whether or not the Customer shall be able to control such use (or misuse);
 - the Customer shall have given to the Company reasonable notice of the defect as soon as reasonably practicable;
 - as soon as reasonably practicable the Customer shall have either returned the goods to the Company or provided authority for the Company's servants or agents to inspect them, as the Company may request. The Company shall have no other or further liability in respect of any direct or consequential loss or damage sustained by the Customer arising from or in connection with any such defect.
- All goods sold by the Company are supplied with terms implied by Section 12 of the Sale of Goods Act 1979 and where the Customer is not dealing or holding himself out as dealing in the course of a business sections 13, 14 and 15 thereof. Subject to the Company providing a warranty in the Terms of that provided by the manufacturer and whether or not the Contract is a contract of sale, all other conditions, warranties and other terms express or implied, statutory or otherwise, are expressly excluded, save insofar as contained herein or as otherwise expressly agreed by the Company in writing PROVIDED that if and insofar as any legislation or any order made thereunder shall make or have made it unlawful to exclude or purport to exclude from the Contract any term or shall have made unenforceable any attempt to exclude any such term, the foregoing provisions of this paragraph will not apply to any such term.
- Save as hereinbefore provided and subject to the provision of Section 2(l) of Unfair Contract Terms Act 1977 the Company shall not be liable to the Customer for any damage or for any direct or consequential loss incurred by the Customer in consequence of any negligence on the part of its servants or agents in or in connection with the supply of any goods.

9. Title

- The following provisions shall apply to all Contracts. No failure by the Company to endorse strict compliance by the Customer with such provisions shall constitute a waiver thereof and no termination of the Contract shall prejudice limit or extinguish the Company's rights under this paragraph. Payment shall mean payment in cash such that the Company's acceptance of a cheque shall constitute conditional payment only until such cheque has been cleared and cash received.
 - Upon delivery of the goods the Customer shall hold the goods solely as bailee for the Company and the goods shall remain the property of the Company until such time as the Customer shall have paid to the Company the full purchase price of all goods supplied under the Contract or any other contract. Until such time the Company shall be entitled to recover the goods or any part thereof and for the purpose of exercising such rights the Company, its employees and agents with appropriate transport may enter upon the Customer's premises and any other location where the goods are situated.
 - Before payment in full is made the Customer shall have power to resell the goods as principal towards the sub-customer, but as agent and fiduciary between the Customer and the Company, the proceeds of sale thereby arising belonging accordingly to the Company.
 - The Customer shall maintain all appropriate insurance in respect of the goods from the date or dates on which the risk therein passes to it. In the event of any loss or damage occurring while the goods remain the property of the Company the Customer shall immediately on receipt of the insurance monies, remit to the Company the full purchase price of the goods lost or damaged less any part thereof which has already been paid and until such amount has been so remitted shall hold such amount as trustee and agent for the Company.
 - The licence granted under sub-paragraph (ii) above shall be terminable forthwith at any time upon notice by the Company to the Customer and in any event shall terminate automatically upon the happening of any of the following:-
 - if payments to the Company on any account are delayed beyond the due date for payment;

- if any cheque promissory note bill of exchange or any other negotiable instrument tendered by the Customer shall be dishonoured on first presentation; or
- if the Customer shall enter into any composition or any arrangement with his creditors or if the Customer being a corporation shall have an administrative receiver or administrator appointed or shall pass a resolution for winding-up or a Court shall make an order to that effect or if there shall be breach of any of the terms and conditions hereof.

10. Lien

The Company shall have a general lien over all goods and property of the Customer (whether worked on or not) in the possession of the Company for all unpaid debts due from the Customer and the Company reserves the right upon the expiration of fourteen days notice to dispose of such goods or property and to apply the proceeds of sale (net of costs of sale) towards the payment of such debts.

11. Exports

1. Definitions

In these conditions

“**the Company**” means Signet Armorlite Europe Limited
 “**the Customer**” means the individual firm company or other party with whom the Company contracts.

“**Supply**” includes (but is not limited to) any supply under a contract of sale. For the purposes of these conditions a quotation shall include the listing of a product in the Company's current price list as varied by any authorised representative of the Company.

2. General

- Previous dealings between the Company and the Customer shall not vary or replace these terms or be deemed in any circumstances whatsoever so to do.
- No order in pursuance of any quotation or otherwise shall be binding on the Company unless and until such order is accepted by the Company either in writing (which shall include e-mail acknowledgement) or by despatch of the goods ordered. In the case of orders placed through the Company's website, the Customer accepts these conditions by submitting such order. Any contract made between the Company and the Customer (herein called “the Contract”) shall be subject to these conditions and save as aftermentioned no representative or agent of the Company has authority to agree any terms or make any representations inconsistent with them or to enter into any Contract except on the basis of them; any such terms representations or Contract will bind the Company only if in writing and signed by a director.
- Unless otherwise agreed in writing by the company these conditions shall override any terms and conditions stipulated or referred to by the Customer in his order or pre-contract negotiations.
- Any description contained in the Company's catalogues, samples, price lists or other advertising material is intended merely to present a general picture of the Company's products and shall not form a representation or be part of the Contract. All promotional material, price lists, catalogues and other documents prepared by the Company together with the “Presenter” provided for the Customer's use are and will at all times remain the property of the Company and without prejudice to the generality of the foregoing, no drawings or information therein may be copied or reproduced in whole or in part or divulged or transferred to a third party except in the promotion of the Company's products without the Company's written consent.
- In the event that the Company has not given a written acknowledgement of the Customer's order these conditions, provided the Customer shall have had prior notice of them, shall nonetheless apply to the Contract.
- The Company reserves the right to correct any clerical or typographical errors made by its employees at any time. Failure by the Company to enforce any of these conditions shall not be construed as a waiver of any of the Company's rights under the conditions of the Contract.

3. Design and Quality

- The goods supplied under a Contract shall correspond as much as possible with the Company's specification of the goods and shall be of merchantable quality but no warranty is given or shall be implied as to the suitability of the goods for any specific purpose.
- The Company reserves the right to make variations in the design and technical specification of the goods without imposing any obligation upon itself to incorporate such changes with products previously supplied.
- The Company does not nor will it assert or warrant the validity of any letters patent registered design or trade mark applying or applied to any goods supplied by the Company to the Customer under a Contract or that any dealing with any such goods is not or will not be an infringement of any patent design or trade mark rights of third parties.
- All goods will be made within reasonable manufacturing limits

of dimensions. If special accuracy is required the Customer must state specifically in writing the maximum and minimum limits. The Company accepts no responsibility for the accuracy of information or drawings supplied by the Company.

4. Prices

- Subject to any agreement to the contrary the Company's quotations are provisional and may be altered to take account of any changes taking place between the date of quotation and the Company's acceptance of the Customer's order in the price of the products to be supplied and other costs of sale (including any such increase arising from adverse movements in the rate of exchange between the £STG and the currency in which the supply to the Company by the relevant supplier is designated) or in the Customer's instructions or in the event that the Customer orders part only of the quantity referred to in any quotation.
- The Company shall be entitled to increase its prices at any time to take account of any increase in the cost to the Company of purchasing any goods or materials (including any such increase arising from adverse movements in the rate of exchange between the £STG and the currency in which the supply to the Company by the relevant supplier is designated)/(including any such increase arising from any error or inadequacy in any instructions provided by the Customer) and such increased prices ruling at the date of despatch by the Company shall be substituted for the previous Contract price. All prices quoted are exclusive of VAT and the Customer shall pay any and all taxes duties and other government charges payable in respect of the goods.

5. Delivery

- Unless otherwise agreed in writing by the Company the Company agrees to deliver goods to the Customer which shall forthwith give to the Company all necessary instructions to enable such delivery to take place; the Company shall add to the Contract price of the goods a reasonable charge for packaging and delivery and off-loading shall be at the Customer's risk and expense.
- Subject to any agreement in writing by the Company, the risk in goods which the Company agrees to supply within the United Kingdom shall pass to the Customer on delivery or the date (if earlier) on which, the goods being ready for delivery, delivery is postponed at the Customer's request.
- Subject to any agreement in writing by the Company, the risk in goods which the Company agrees to supply outside the United Kingdom shall pass to the Customer in accordance with F.O.B. English Port as defined in Incoterms 1990.
- Should the Customer be unable to accept delivery of the goods at the time when the goods are available for delivery the Company may at its absolute discretion store the goods until actual delivery and the Customer shall be liable to the Company for the reasonable costs of storage handling and carriage. This provision shall be without prejudice to the Customer's liability in damages for failure to take delivery on the contractual date.
- The Company shall not be liable for any loss of or damage sustained by any goods left with the Company howsoever caused and whether or not attributable to negligence on the part of the Company or negligence or willful default on the part of any servant or agent of the Company.
- No claim for damage in transit shortage of delivery or loss of goods will be entertained by the Company unless (1) the Customer shall give to the Company written notice of such damage, shortage or loss either within such time as will enable the Company to comply with the carrier's conditions of carriage or three days, whichever is the shorter, and (2) where the goods have not been checked on acceptance from the carrier, the delivery book of the carrier has been signed “not examined”.
- Should the Company be delayed in or prevented from making delivery of the goods due to war, governmental or parliamentary restrictions, strike, lock-outs, fire, floods, explosions, labour disturbances, trade disputes, damage to or destruction of the goods, breakdown of machinery, shortages of labour or of raw materials or Act of God or due to any other cause whatsoever beyond the

reasonable control of the Company, the Company shall be at liberty to cancel or suspend the order placed by the Customer without incurring any liability for any loss or damage arising there-from.

- While the Company will endeavour to deliver the goods by any date or within any period agreed upon, such dates and periods are estimates only given in good faith and the Company will not be liable for any failure to deliver by such date or within such period. Moreover, the Company shall be entitled to defer delivery until any monies due from the Customer have been received.
- The Company may deliver the goods in instalments unless otherwise agreed. When delivery by instalments is specified each delivery shall for the purpose of this sub-clause only be deemed to constitute a separate contract and the failure of any one or more deliveries shall not be deemed to be a repudiation of the Contract.
- Save as provided by paragraph 7 hereof the Customer shall not be entitled to return goods or refuse to accept delivery without the Company's prior written consent.

6. Payment Terms

- For the purpose of this paragraph the goods shall mean the whole or any instalment of the goods which the Company has agreed to supply and the relevant date shall be the date on which
 - the Company despatches the goods or
 - the Customer defaults in its obligations under sub-paragraph (b) hereof whichever shall first occur.
- Unless otherwise specified in writing by the Company payment shall be made by the Customer net cash not later than 25 days from the statement date. Time for payment shall be of the essence of the contract. Without prejudice to any other rights of the Company interest will be payable on all overdue accounts at 2% per month and the Company shall be entitled to recover all other costs or expenses incurred and for the purpose of paragraphs 7 and 9 hereof the full purchase price of the goods shall include delivery and packaging charges together with any interest payable and costs hereunder. In the case where overdue balances occur we will add collection costs. The Customer shall not be entitled to withhold or set off payment of any amount payable to the Company under this or any other Contract by reason of any dispute which it may have with the Company.
- Without prejudice to any other terms herein if payments to the Company on any account are delayed beyond the due date for payment or if the Customer shall enter into any composition or any arrangement with his creditors or if the Customer being a corporation shall have an administrative receiver or administrator appointed or shall pass a resolution for winding-up or a Court shall make an order to that effect or if there shall be breach of any of the terms and conditions hereof the Company shall be entitled to withdraw credit facilities from the Customer.

7. Cancellation

- If the Customer shall fail to make any payment when it becomes due or shall enter into any composition or any arrangement with his creditors or if being a corporation shall enter into a corporate voluntary arrangement or have an administrative receiver or administrator appointed or shall pass a resolution for winding up or a Court shall make an order to that effect or if there shall be any breach by the Customer of any of the terms and conditions hereof the Company may defer or cancel any further deliveries and treat the Contract of which these conditions form part as determine but without prejudice to its rights to the full purchase price for goods delivered and damages for any loss suffered in consequence of such determination.
- Cancellation by the Customer will only be accepted at the discretion of the Company and in any case on condition that any costs or expenses incurred by the Company up to the date of cancellation and all loss or damage resulting to the Company by reason of such cancellation will be paid by the Customer to the Company forthwith. Acceptance of such cancellation will only be binding on the Company if in writing.

8. Warranty

- Save as otherwise provided in these conditions and with the exception of goods supplied with specific warranty the Company's liability in respect of any defect in or failure of goods supplied is limited to replacing or repairing or paying for the repair or replacement of goods which within a reasonable period after delivery to the Customer are proved to be defective by reason of faulty or incorrect workmanship or materials PROVIDED that the Company's liability (if any) in respect of any direct loss or damage sustained by the Customer as a result of such defect shall not exceed the price of the goods. Conditions precedent to the Company's liability (if any) hereunder shall be that
 - the goods shall have been subject to reasonable and proper use by the user thereof whether or not the Customer shall be able to control such use;
 - the Customer shall have given to the Company reasonable notice of the defect as soon as reasonably practicable;
 - as soon as reasonably practicable the Customer shall have either returned the goods to the Company or provided authority for the Company's servants or agents to inspect them, as the Company may request. The Company shall have no other or further liability in respect of any direct or consequential loss or damage sustained by the Customer arising from or in connection with any such defect.
- All goods sold by the Company are supplied with terms implied by Section 12 of the Sale of Goods Act 1979 and where the Customer is not dealing or holding himself out as dealing in the course of a business sections 13, 14 and 15 thereof. Subject to the Company providing a warranty in the Terms of that provided by the manufacturer and whether or not the Contract is a contract of sale, all other conditions, warranties and other terms express or implied, statutory or otherwise, are expressly excluded, save insofar as contained herein or as otherwise expressly agreed by the Company in writing PROVIDED that if and insofar as any legislation or any order made thereunder shall make or have made it unlawful to exclude or purport to exclude from the Contract any term or shall have made unenforceable any attempt to exclude any such term, the foregoing provisions of this paragraph will not apply to any such term.
- Save as hereinbefore provided and subject to the provision of Section 2(l) of Unfair Contract Terms Act 1977 the Company shall not be liable to the Customer for any damage or for any direct or consequential loss incurred by the Customer in consequence of any negligence on the part of its servants or agents in or in connection with the supply of any goods.

9. Title

- The following provisions shall apply to all Contracts. No failure by the Company to endorse strict compliance by the Customer with such provisions shall constitute a waiver thereof and no termination of the Contract shall prejudice limit or extinguish the Company's rights under this paragraph. Payment shall mean payment in cash such that the Company's acceptance of a cheque shall constitute conditional payment only until such cheque has been cleared and cash received.
 - Upon delivery of the goods the Customer shall hold the goods solely as bailee for the Company and the goods shall remain the property of the Company until such time as the Customer shall have paid to the Company the full purchase price of all goods supplied under the Contract or any other contract. Until such time the Company shall be entitled to recover the goods or any part thereof and for the purpose of exercising such rights the Company, its employees and agents with appropriate transport may enter upon the Customer's premises and any other location where the goods are situated.
 - Before payment in full is made the Customer shall have power to resell the goods as principal towards the sub-customer, but as agent and fiduciary between the Customer and the Company, the proceeds of sale thereby arising belonging accordingly to the Company.
 - The Customer shall maintain all appropriate insurance in respect of the goods from the date or dates on which the risk therein passes to it. In the event of any loss or damage occurring while the goods remain the property of the Company the Customer shall immediately on receipt of the insurance monies, remit to the Company the full purchase price of the goods lost or damaged less any part thereof which has already been paid and until such amount has been so remitted shall hold such amount as trustee and agent for the Company.
 - The licence granted under sub-paragraph (ii) above shall be terminable forthwith at any time upon notice by the Company to the Customer and in any event shall terminate automatically upon the happening of any of the following:-
 - if payments to the Company on any account are delayed beyond the due date for payment;

- if any cheque promissory note bill of exchange or any other negotiable instrument tendered by the Customer shall be dishonoured on first presentation; or
- if the Customer shall enter into any composition or any arrangement with his creditors or if the Customer being a corporation shall have an administrative receiver or administrator appointed or shall pass a resolution for winding-up or a Court shall make an order to that effect or if there shall be breach of any of the terms and conditions hereof.

10. Lien

The Company shall have a general lien over all goods and property of the Customer (whether worked on or not) in the possession of the Company for all unpaid debts due from the Customer and the Company reserves the right upon the expiration of fourteen days notice to dispose of such goods or property and to apply the proceeds of sale (net of costs of sale) towards the payment of such debts.

11. Exports

- In respect of sales of goods outside the United Kingdom (“Export Sales”) the provisions of these conditions shall apply unless inconsistent with the terms of this clause.
- Unless otherwise specifically agreed between the Company and the Customer all Export Sales shall be made:-
 - In the case of existing customers, C.I.F. to the Customers premises and the Company's prices shall be increased to cover the Company's costs in making such deliveries and
 - In the case of new customers, F.O.B. UK Port of Loading.
- Unless otherwise agreed in writing, payment for Export Sales shall be by Confirmed Irrevocable Letter of Credit (“CILC”) issued by a United Kingdom Bank. Such CILC shall allow for transshipment, partial shipment and shall be transferable by the Company.
- The Customer warrants that if an import licence or permit is required for the importation of the goods into the country of destination then such import licence or permit has been obtained or will be obtained prior to shipment.

12. Data Protection Act 1998

- The Customer consents under the Data Protection Act 1998 to the processing of its personal data for the purpose of the Company's business and associated activities, and the passing of this data to credit reference agencies, banks, credit insurers and other responsible organisations.

13. Jurisdiction

- The proper law of all Contracts with the Company shall be English Law which shall govern in all respects the construction and effect of such Contracts and of these conditions. The Customer agrees that in the event of any dispute arising out of the Contract or the performance thereof it will submit to the exclusive jurisdiction of the English Courts.
- These conditions shall not affect the statutory rights of a consumer and nothing in these conditions shall exclude or restrict any liability that the Company may have by virtue of the Consumer Protection Act 1987.

Terms of Acceptance

In placing an order with this company the customer confirms he has verified the mutual compatibility of customer supplied medical device(s) in accordance with the manufacturer's instructions.

Cancellation or Alteration

The customer will be charged for all work carried out up to the time the order is cancelled or altered.

Queries

Any job returned for query must be accompanied by the original order.

Prices

All prices are pounds sterling and per single lens, unless stated otherwise, and are subject to P&P and VAT. All orders are accepted subject to prices ruling at the date of despatch. Where the use of stock lenses will not produce a satisfactory job due to the frame shape, design and/or lens prescription, surfaced lenses will be supplied at the appropriate additional charge. Lens products not shown are charged at nett plus VAT.

Ordering

Use and application of D25 Segs

HORIZONTAL PLACEMENT

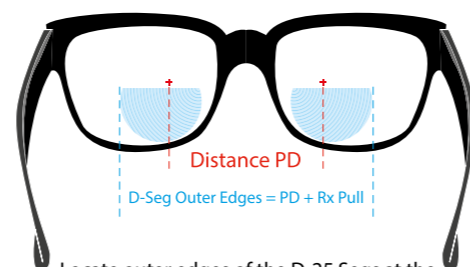
To ensure proper horizontal positioning of D25 Segs +3.00D and above, dot the front surface of the spectacle lens in the conventional manner to indicate the distance PD. Referring to the illustration, determine the appropriate distance between the outside edges of the segs and mark this distance on the front surface of the spectacle lenses. For example, Distance PD = 61mm and distance Rx = -3D; so the distance between the outside edge of segs should be equal to 81mm.

SEGMENT HEIGHT

If the prescribed height of the D-25 Seg requires trimming, the vertical dimension should be reduced by cutting from the bottom of the seg. This will preserve the optical correction of the D-25 Seg. Place a razor blade at the desired position on the segment and press straight down against a flat, hard surface to obtain a sharp edge.

Each package contains both right and left seg. Be sure the optical centre of each seg is decentred nasalward. The optical centre of each seg is easily identified by the position of the smallest concentric circle in each segment. Normally the top edges of the segs should be level with each other.

Application of 3M Press-On™ Optics

QUICK AND EASY TO APPLY

Both sphere and prism Press-on Optics can be applied to either part of or the entire lens. Avoid exposing Press-on optics to dust, dirt or grease during application.

1) With a felt tip pen, mark the optical centre onto the lens. This is important with sphere placement only. The optical centre is the smallest concentric ring. The base orientation of the optic is indicated with the word 'base'. Position the Press-On Optic with the optical centre aligned and the smooth side down facing the inside surface of the spectacles.

2a) If the lens is out of the frame; with scissors, cut the Press-On Optic to the size of the lens. With a razor blade held at the angle of the bevel, carefully trim the Press-on optic flush with the edge of the spectacle lens.

2b) If the lens is in a frame; with a felt tip pen, trace the lens onto the Press-On Optic just inside the rim of the frame. Remove the Press-On Optic from the spectacle lens and carefully cut out the Press-On Optic inside the line.

Note: the Press-On Optic, after cutting, must not overlap the bevel or touch the frame.

3) Wash the spectacle lens and the Press-On Optic with a weak solution of dish washing detergent (free of lotion) to remove grease and dirt. Rinse thoroughly. Submerge the spectacles and Press-On Optic in a bowl of warm water or under a running tap. Wipe away any air bubbles clinging to either surface.

4) Reposition the Press-on Optics and remove the spectacles from the water, holding the Press-On Optic in place. Adjustments can be made by sliding the Press-On Optic. Press dry.

Note: when applying to a plastic lens, the Press-On Optic may be difficult to slide. Repositioning may require removal and reapplication.

5) If the lenses are out of the frame, reinsert into the frame.

6) Inspect the edges to check no overlapping occurs onto the frames. Remove and reapply if dust or air bubbles are trapped between the Press-On Optic and the lens. Handle spectacles gently for 24hrs following application. Faint, grey patches that may develop are temporary and usually disappear as drying is completed.

Note: Alcohol is not recommended for repeated application of the optics.
